- Affidavit of Compliance with the federal work authorization program;
- E-Verify Memorandum of Understanding (15 CSR 60-15.020).

The City will use the information that is included in this package to determine the most qualified firm or team during the selection process. Suggested information to include in the letter are: the experience of the persons or team proposed to be assigned to each phase of the project, a description of other active or past projects performed by your company that demonstrate the your company's ability, references or contacts of current or past clients who can attest to your company's performance, and any other information that will accurately portray the competence, capability, and past record of your firm or team.


