Sealed bids must be submitted for the project on the unbound Bid Form set included with the Bidding Documents. Bid envelopes must state "Newburg SRTS". Failure to state this on the bid envelope may result in the bid being returned without being considered. Each bidder must submit a bid security in the amount of five percent (5%) of their total bid.

The Owner reserves the right to reject any or all bids, to waive informalities or irregularities, and to determine the lowest responsive and responsible Bidder, and to award the contract on that basis.

The wage rates applicable to this project have been predetermined as required by law and are set forth in this appendices. When Federal wage rates are application and included, this contract is subject to the "Work House Act of 1962", (P.L. 87-581: 76 Stat. 357) and implementing regulations.
