

INVITATION FOR BIDS

Sealed bids for the City of Festus, Sunshine Drive & W. Main Street Improvements (hereinafter "Project") will be received by Festus City Hall, 711 West Main Street, Festus, Missouri 63028, until 2:00 p.m. local time, on Tuesday, December 7, 2010. The bids will be publicly opened and read aloud at 2:05 p.m. at Festus City Hall.

The Scope of Work includes street improvements to Sunshine Drive and W. Main Street within the City of Festus and provides for new storm sewer, concrete sidewalk, concrete curb and gutter, pavement reconstruction, pavement milling, asphalt overlay, street lighting, traffic control and other incidental items and work described in the Project Documents, or reasonably inferable therefrom.

Bid packages will be available on Monday, October 25, 2010 and may be obtained from the Sunset Hills office of Cochran located at 12963 Maurer Industrial Drive, Sunset Hills, MO 63127, upon payment of a non-refundable fee of \$100.00 per set. For directions, please call 314-842-4033.

A bid security in the amount of five percent (5%) of the bid amount must accompany each bid, in accordance with the Instructions to Bidders.

The City of Festus anticipates issuing notice to proceed in the Spring of 2011.

For a contractor to be awarded this project the contractor must have a fully responsive contractor questionnaire on file with the Missouri Highway and Transportation Commission at least 7 days prior to the bid opening date.

The wage rates applicable to this project have been predetermined as required by law and are set forth in this specification. When Federal wage rates are applicable and included, this contract is subject to the "Work Hours Act of 1962", (P.L. 87-581: 76 Stat. 357) and implementing regulations. When state and federal wage rates are both required the higher of the two for each job classification shall be used.

Effective January 1, 2009 and pursuant to RSMo 285.530 (1), No business entity or employer shall knowingly employ, hire for employment, or continue to employ an unauthorized alien to perform work within the state of Missouri. The successful bidder must submit a sworn affidavit and documentation affirming the business entity's enrollment and participation in the federal work authorization program and that all of its employees working for the contracted services are not illegal immigrants.

Upon signing the contract, the successful contractor and any subcontractor performing the work shall provide a ten-hour Occupational Safety and Health Administration (OSHA) construction safety program for their on-site employees.

The City of Festus, Missouri hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, disadvantaged business enterprises (DBE) will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin in consideration for an award.

The DBE Contract Goal for this project is 20%, and DBE firms must be certified by MoDOT to attain credit towards this contract goal.

THE OWNER INTENDS TO AWARD THE CONTRACT TO THE MOST RESPONSIVE, RESPONSIBLE BIDDER SUBMITTING THE LOWEST BID. THE OWNER RESERVES THE RIGHT TO REJECT ANY AND ALL BIDS, AND TO WAIVE ANY IRREGULARITIES IN THE BEST INTEREST OF THE OWNER WITH MODOT'S CONSENT.
