

INVITATION TO BID

Pettis County Bridge Replacement

Sealed bids for Pettis County Katy Trail Bridge Over US 50 TAP-3301 (497), will be received at: 415 S. Ohio, Suite 212, Sedalia, MO 65301 until 10am on the 14th day of October, 2015, at the office of the Pettis County Commission, and at that time will be publicly opened and read. All bids shall be submitted in the form of a hard copy.

1. The proposed work includes the removal of 2 existing 60' bridges and construction of one 60'-6" long, 0 degree skew, single-span bridge using a pre-engineered shop fabricated steel truss, concrete deck, and existing concrete abutment modifications on the KATY Trail in Pettis County MO over US 50 Highway in Sedalia.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The Pettis County Commission hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award."

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

The contract, if awarded, will be awarded to the lowest, responsive, responsible bidder complying with the Conditions of the Contract Documents within the Owner's budget. The Bidder to whom the awards are made will be notified at the earliest possible date. The Owner, however, reserves the right to reject any and all Bids and to waive any informality in Bids received whenever such rejection or waiver is in his interest.

The DBE Goal for this project is 8%.

No 2nd tier subcontracting will be allowed on this project.
