Re: Request For Information (RFI) –Official Missouri Highway Map Production (hereinafter referred to as “map”).

Dear Potential Vendor:

The Missouri Department of Transportation (MoDOT) is researching the production of our state map at no cost to MoDOT. We need your assistance in the parameters required for such an arrangement. MoDOT may develop the required competitive solicitation documents using the information received from the responses to this RFI as well as other research performed by the department.

Background:

- MoDOT distributes approximately 2,750,000 highway maps at no charge to the division of tourism, legislative bodies, and to our rest areas/welcome centers throughout the state. They are also mailed to constituents upon request.
- MoDOT is interested in the vendor performing all services associated with the map including production, storage and distribution.
- The current size of the map is 28-7/8” x 39-1/2”. The size of the map and some content is negotiable. A few minimum components required at this time are; it must be printed in six-color, include MoDOT contact information, Governor’s picture with message and the Missouri Highway Commissioner contact information.

- To respond to an RFB/RFP of this nature, what information would you require in the solicitation document?
- What information should respondents or offerors provide to ensure the best firm is selected?
- To result in the most advantageous agreement, what should be the responsibility of MoDOT and what should be the responsibility of the contractor?
- Provide contact information for any other similar RFB/RFP’s you have responded to in the past.
