* Award of this solicitation was made on an "All Or Nothing" basis using the "lowest and best" principle of award, by calculating the total cost of purchasing one of each filter listed on the original bid sheet. Since, in some cases not all filters were bid, the cost of items not bid was removed from all vendors bids to arrive at the adjusted total bid listed, with preference being given to vendors who could supply the majority of the listed filters.

Factory Motor Parts submitted a response, which was missing two of the five bid pricing sheets and could not be considered in this tabulation.

Champion Brands and Wyatt Automotive each submitted a "No Bid" response, but asked to be kept on the bidder's list for future opportunities.

Notification of the online posting of this solicitation was also sent to Jefferson City Auto Supply (WBE vendor) and Midway Freightliner, but no responses were received from these vendors.
