

Awarded to the 2nd-low quote - Per Brad Gates, D2 Maintenance Superintendent. The 2nd-low quote was for a 21 HP versus a 19 HP engine. Also, the low-quoter's location was at the very edge of the parts and servicing location area required in the RFQ, which was to be within 75 miles of the delivery location (Chillicothe, MO). According to Mapquest, this dealer's location, at St. Joseph, MO, is 77 miles from Chillicothe, MO. Brad felt the extra \$490 would be saved over the life of the unit by his crews at Chillicothe being able to obtain parts and servicing more immediately and without delays in shipping/receiving parts and less travel time/mileage to/from the 2nd-low dealer's location in Bucklin, MO.

Marshall Service Co. also submitted an alternate quote on a unit w/ a 52" deck. This was not considered since it did not meet the minimum specs.

"No Quote" responses were received from Lee's Lawn Care, The Square Deal Store, and Sunrise Tractor. The following vendors were provided notification of the online posting of this RFQ opportunity, but no responses were received from Cooke Sales & Service, Davis Lawn Equipment, Fehling Small Engine, Heartland Farm & Lawn, Jeff Davis Sales & Service, Scott's Tractor, or St. Joseph Tractor.
